The Logotypes

The logotype symbolises the connection, through the common geographical parts of the participating countries. The shape was formed from the capital starting letters of the country names in their original languages - "Magyarország" and "Slovak Republic".

The capital "M" which appears in the upper part of the shape forms hills, mountains and castle, the "S" as a projection of the "M" in the bottom, is a metaphor for a river and road.

The "blue" color indicates the Slovak Republic, while the "green" color indicates Hungary (Magyarország). The logos must not be changed!

The logo also exists in a version with the text "European Regional Development Fund" written below it. The height of this line is the same as for "European Union" under the flag.

The placement of this line can be if possible on the page where e-mail, website address etc. under availabilities, but it must be visible and legible.

If the option to make reference to the fund separately from the logo is chosen, this line can be written in any typeface that matches the design of the publication, but no smaller than 7.5 points. If the full harmonized Interreg branding is used, it should be written in the fonts Open Sans regular or Vollkorn regular. The placement of this line can be anywhere on the page where the logo is used, but it must be visible and legible.

Proportion



The composition of the logo elements follows specific rules and must not be changed.

Basic unit

The basic unit used for definition of the logo composition is the width of the letter "e".

European flag

The space between the logotype and the European flag equals 3/4 of the basic unit. The height of the flag is the same as the letter "l".

Clear space area

Around the logo there must be a clear space of at least one basic unit in height and width. Within this area no other graphic elements or logos must be placed. Likewise, this zone has to be observed for the positioning distance to the page margins. This clear space area shown opposite is the minimum clear space – it is recommended to increase this space wherever possible.

The only arrangement option for the logo is the left aligned version. This layout should be used in the three languages and all the different size variations from print materials to digital (on screen) appearances.







Derived version of the logo for small promotional items

If the use of the original logo is not possible due the limited space available on the item a derived version of it is available.



The minimum height of the EU emblem shall be 1 cm.

The European Union text shall be legible.

The European Union emblem shall have at least the same size, measured in height or width, as the SKHU logo.

Do not rotate or mirror the logotype!



Do not scale in any directions!



Do not skew the logotypes!



Do not change the shape and text colour!



Do not swap the logotype colors and do not use inappropriate text colour!



Do not use background colour and effects!

Use of Fonts

Typefaces

Overall communication (body text, headlines etc.).

The typeface for all other applications from body text to headlines is Aller. It has a neutral yet friendly appearance suitable for all applications. Its broad variety of weights and styles makes it very versatile. It was optimized for print, web, and mobile interfaces, and has excellent legibility characteristics in its letterforms.






